Directions to Fairgrounds

From the North - Hwy 41 South to the Hwy 151 exit. Take highway 151 North. Turn left onto Martin Ave. Follow Martin Ave. to the Fairgrounds on the right.

From the South - Hwy 41 North to Hwy 151 exit. Turn right onto Hwy 151 (North). Follow Hwy 151 to Hwy 45. Right (North) onto Hwy 45 and follow to Fairgrounds which will be on the left.

From the East - Hwy 23 West to National Ave. Turn left onto National Ave. and follow to Hwy 45. Turn right (North) onto Hwy 45 and follow to the Fairgrounds on the left.

From the West - Hwy 23 East to Pioneer Rd. Right onto Pioneer Rd., go to the 6th light and turn left onto Martin Ave. Follow to the Fairgrounds on the right.

Show Rules:

1. This show will be governed by the latest revised rules of the ARBA, and the completion of the entry blank indicates your acceptance of these rules and those rules listed in the catalog.
2. The FVRC will not be responsible in case of fires, accident or providential destruction. Every precaution will be taken to prevent the same.
3. All mailed pre-entries must be postmarked no later than September 21, 2020. Online pre-entries must be completed by September 23, 2020. **Day of Show Entries will not be accepted.**
4. All entries should be on official blanks printed in this catalog; however, entries will be accepted on other forms like the one published on the WSRBA Website. Online entries must be made through www.easy2show.com, find our show under the Enter A Show icon. No e-mailed entries will be accepted.
5. A check or money order must accompany your mailed entry. Entries will not be valid without the proper payment. Online entries must be paid for with a credit or debit card.

8. Open & youth pre-entry fees: single rabbit or cavy & meat pen - \$5.00; fur class - \$5.00.
9. All rabbits must be permanently and legibly marked in the left ear.
10. All fur entries must be entered and in the paid regular class.
11. Only authorized persons will be allowed behind the judges' tables.
12. All placings will be done on control sheets, we will not be using remark cards.
13. We reserve the right to substitute judges or to add judges if the need arises. Every effort will be taken to follow the printed show schedule.
14. Rosettes will be awarded for BOB and BOS in those breeds where 10 or more are shown. This will be taken to the table with the paperwork. No other ribbons will be handed out.
15. Judging will begin promptly at 9:00 a.m. with the opening breeds listed on the second page of the show catalog.
16. From each entry: ten cents (\$0.10) will go to the WSRBA sweepstakes fund, two cents (\$0.02) will go to the Sweepstakes Chairman, and three cents (\$0.03) will go to the Bulletin.
17. All ARBA Show Rules will be followed, including the RHDV2 Show Policy.
18. All animals in the show room must be entered in the show.
19. No additional for sale items will be allowed in the show room.
20. All vendors must be set up outside.
21. Masks are required, and social distancing will be encouraged.
22. Exhibitors are showing at their own risk. The Fox Valley Rabbit Club will not be held liable for any health issues of humans or rabbits. By submitting an entry, all exhibitors and family members agree to this statement.
23. If the show is cancelled, exhibitors will be refunded their full entry fee via check payment from the FVRC.
